# Risk Assessment

## Context

An actual template for risk assessment is not provided, since it heavily relies on the type of processing that is taking place. However, the following questions and table can be used as an input into conducting a risk assessment, or even a full Privacy Impact Assessment (PIA).<sup>‡</sup> The table below provides possible risk sources, and how can they be considered and mitigated. More information is provided in WP29 opinions [WP29-WP248rev.01 <https://ec.europa.eu/newsroom/article29/items/611236> ] and AARC guideline [AARC-G042 <https://aarc-community.org/guidelines/aarc-g042/> ].

### Key questions to commence a risk assessment:

- What type of processing involving personal information is conducted?
- What are the risks associated with these processing activities? What are the mitigation procedures?
- How are processing activities reviewed? Is documentation relevant and up-to-date?
